It is taken from The Conveyancing Map which provides access to extensively refined, cleansed and improved LR housing transaction data and provides an insight into the local and national market landscape.

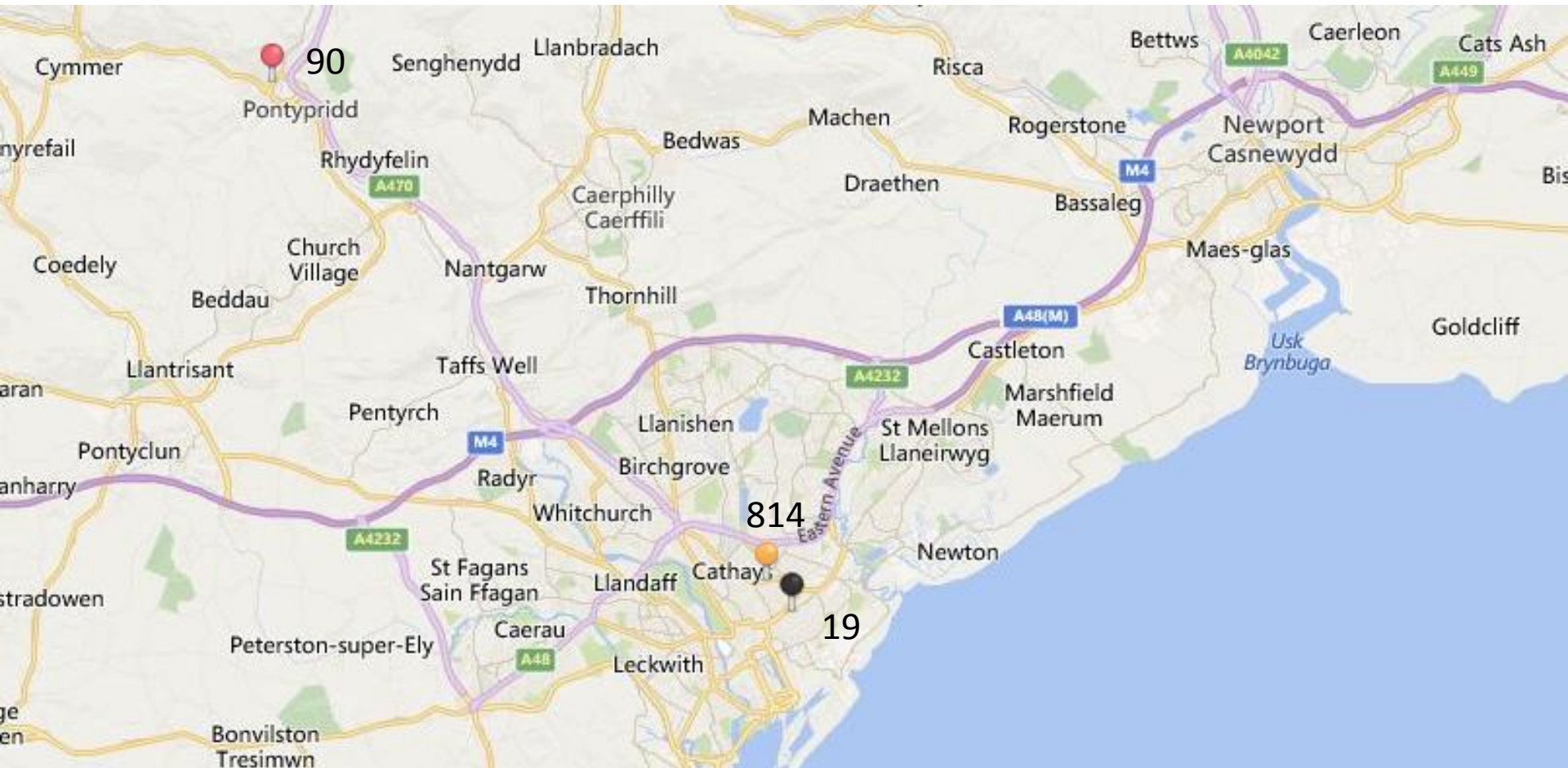


Distribution of residential purchases by Spicketts Battrick Solicitors offices in 2015

2016 Q1/Q2 overview



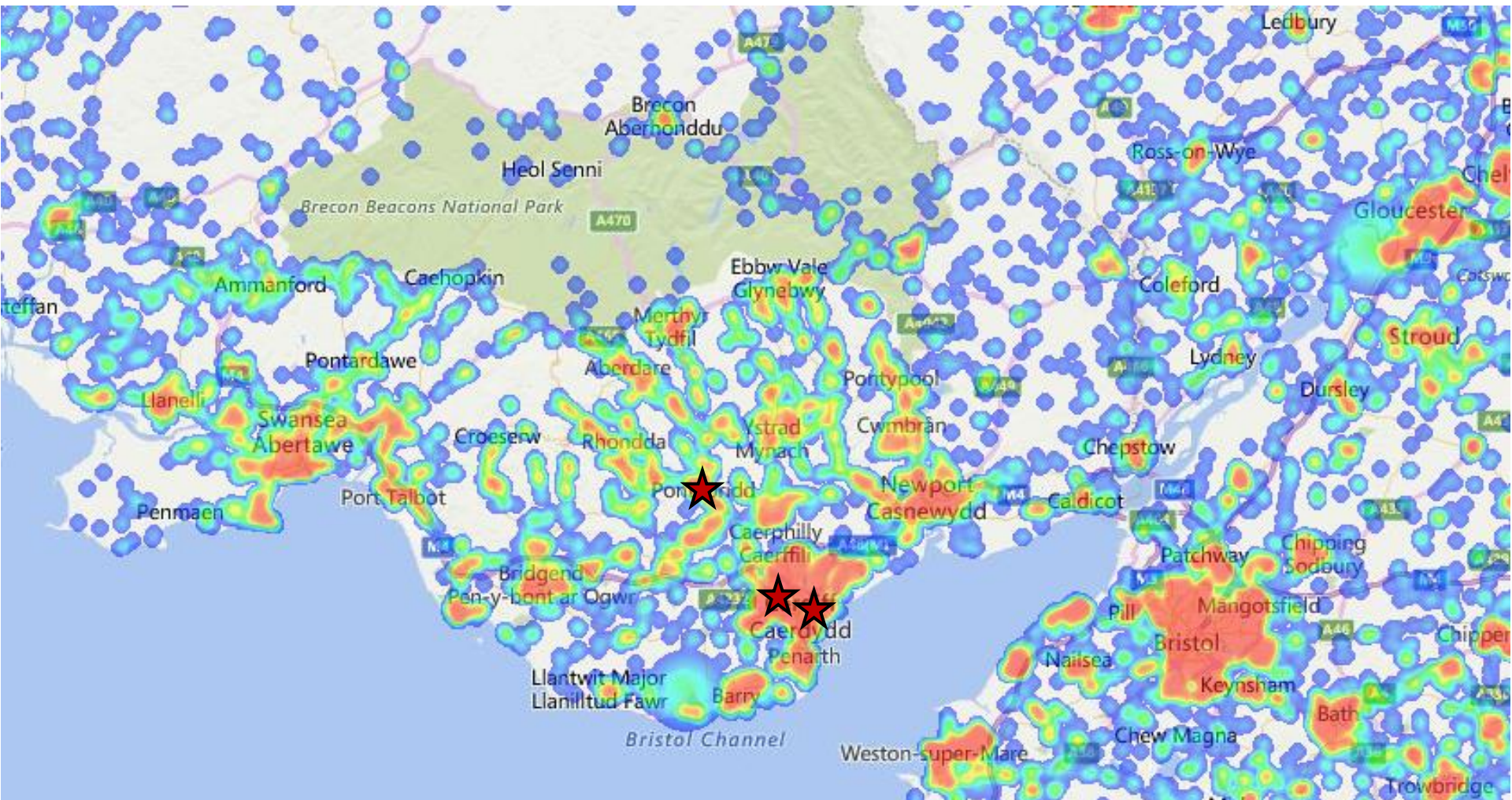
: For comparison, in 2016 Q1/Q2 there were 923 residential purchases.



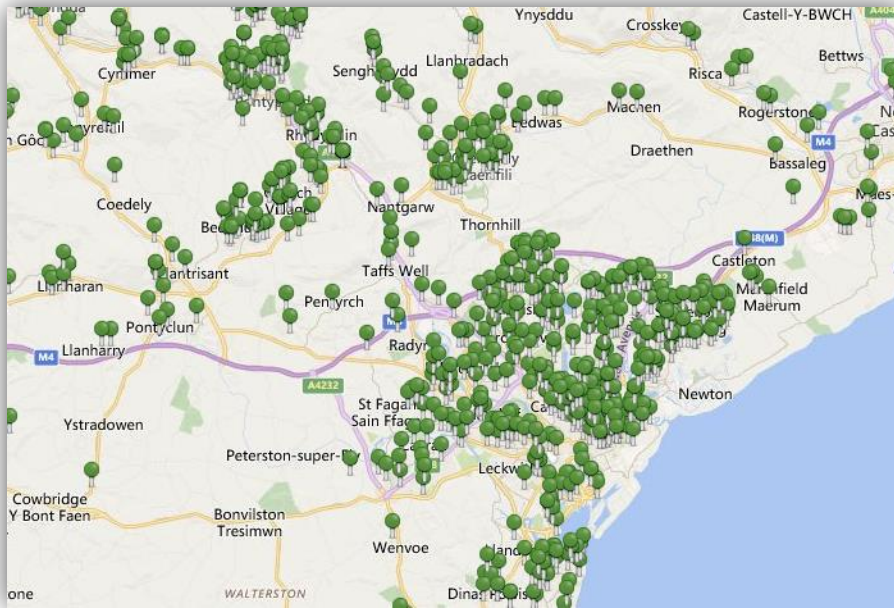
Distribution of residential purchases by Spicketts Battrick Solicitors offices in 2016 Q1/Q2

: A heatmap showing 2015 residential purchase transactions with Spicketts Battrick Solicitors offices superimposed



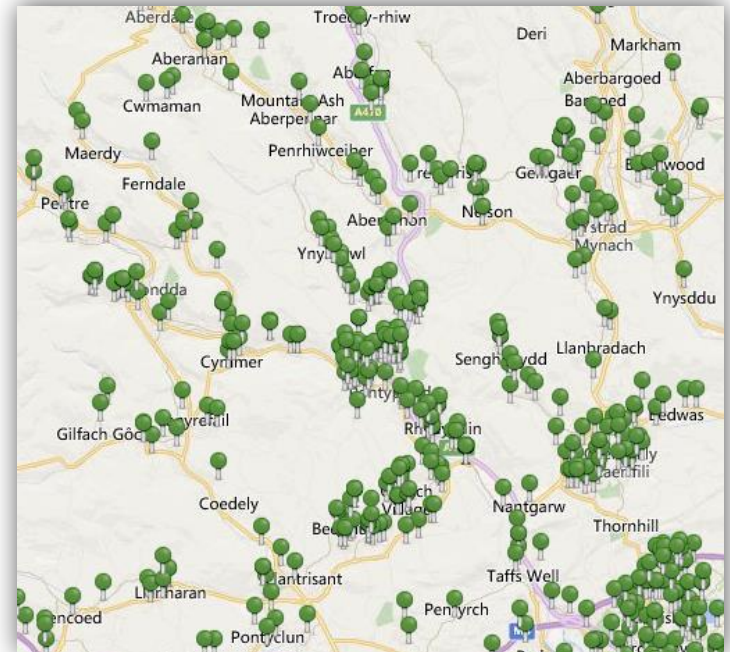

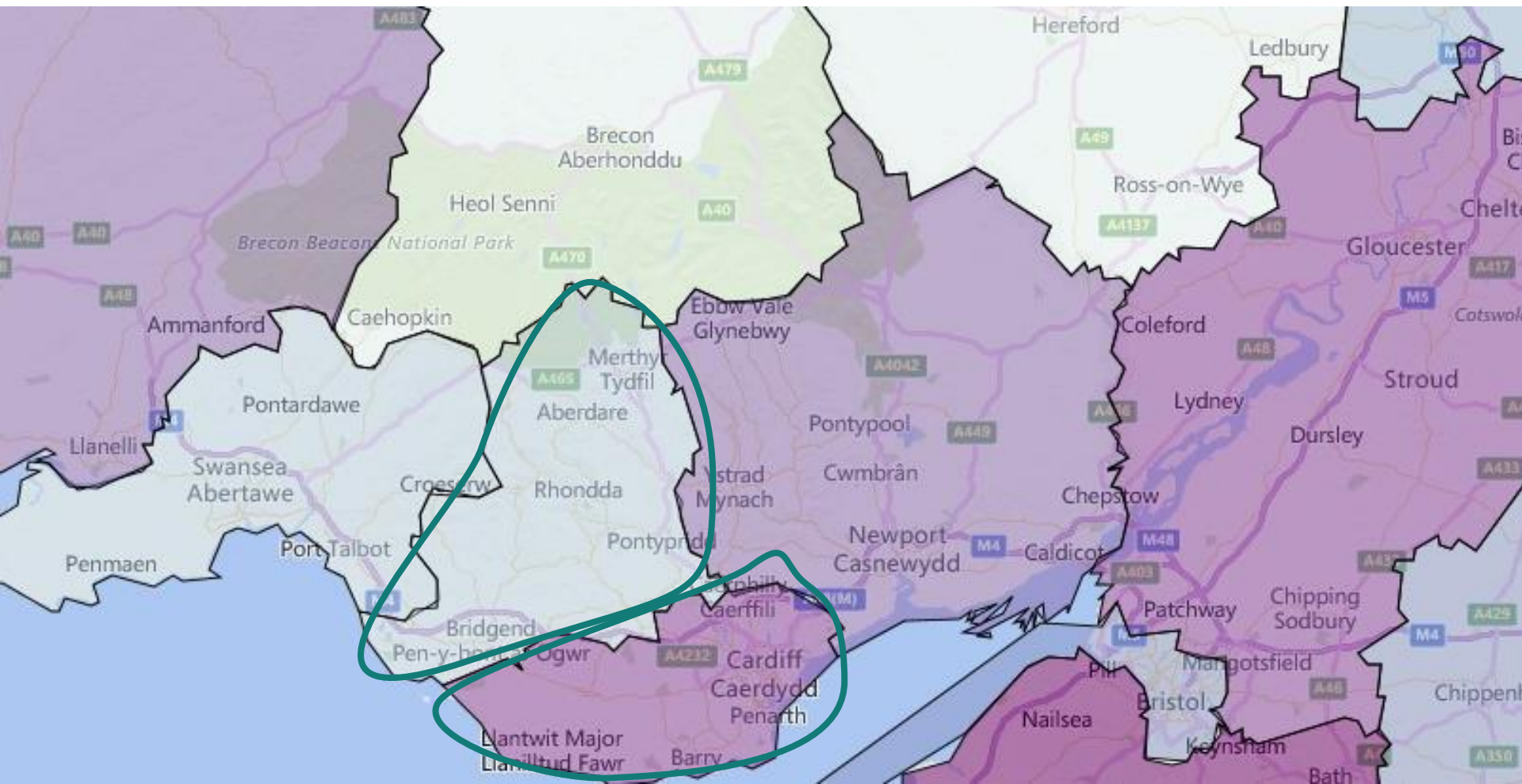

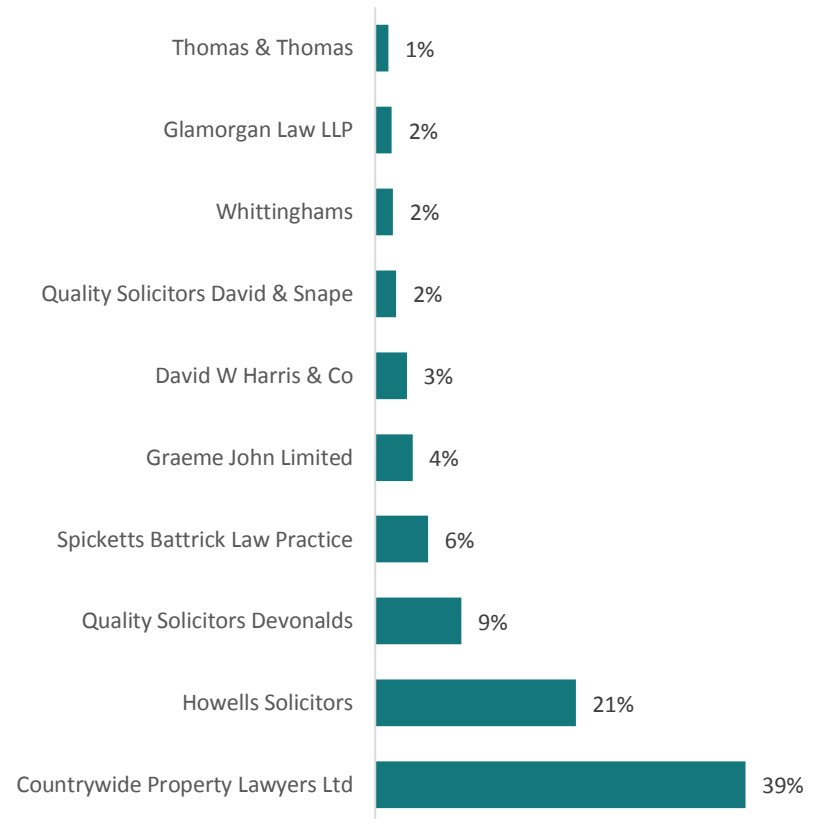


: Spicketts Battrick Solicitors are based Mid and South Glamorgan so for the purpose of this report we have collected the relevant data from these counties.

In 2015 there were 40 conveyancing firms based in Mid Glamorgan that recorded 28,638 purchase transactions nationwide with LR.

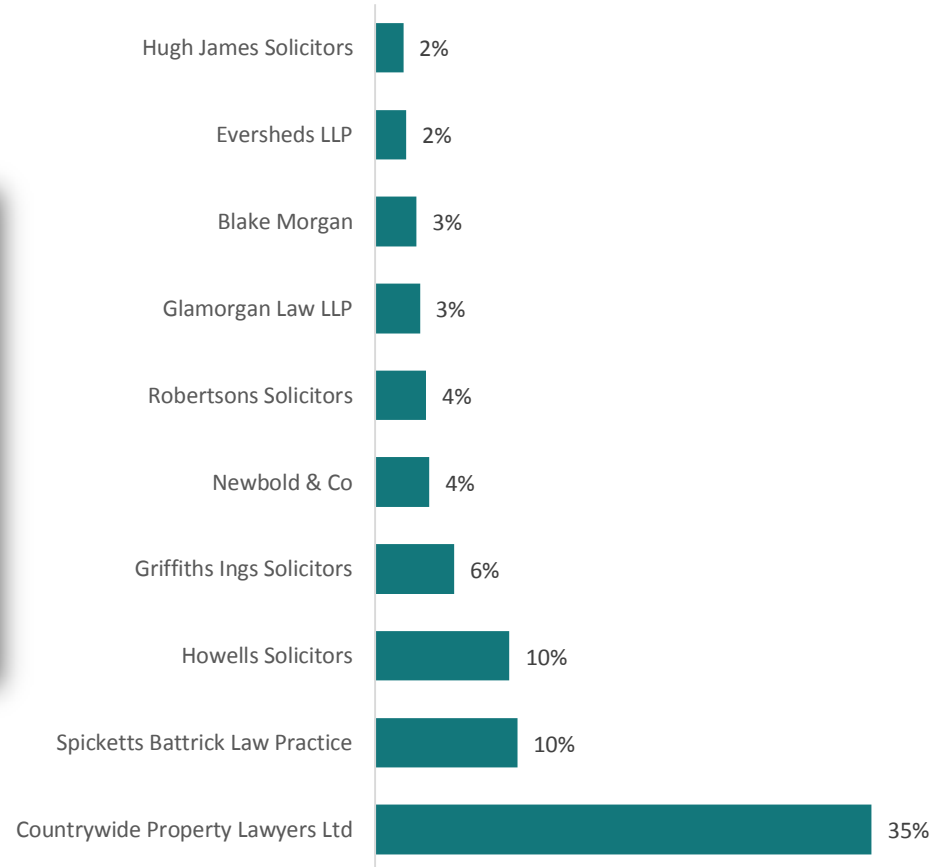


Spickett Battrick Solicitors are within the top 10 firms based in Mid Glamorgan in terms of transaction volumes.

: In 2015 there were 79 conveyancing firms based in South Glamorgan that recorded 31,702 purchase transactions nationwide with LR.



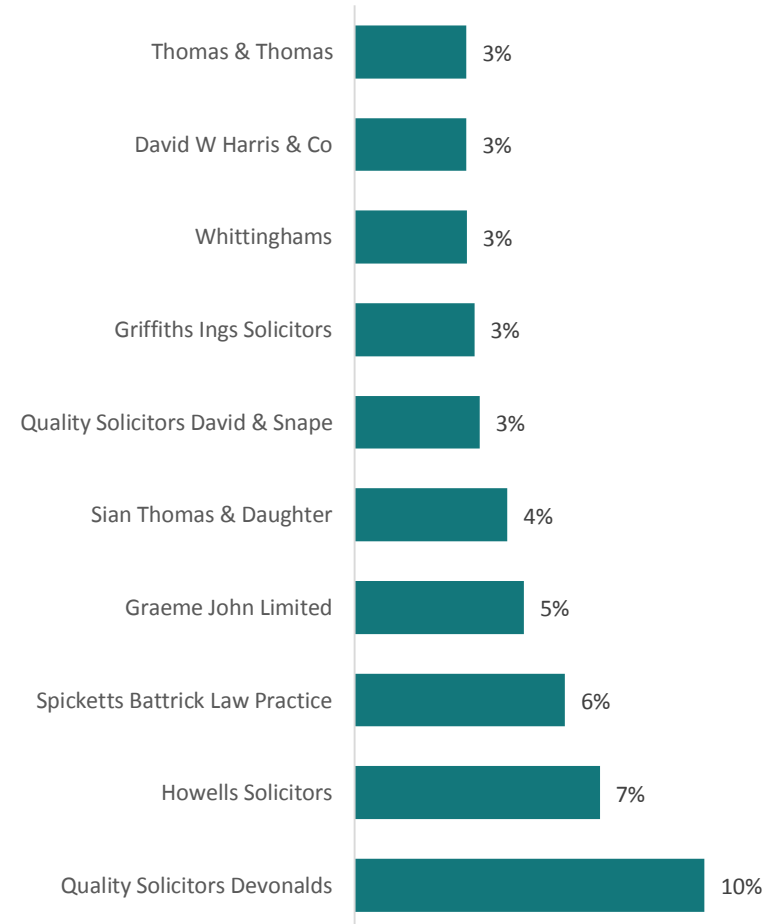
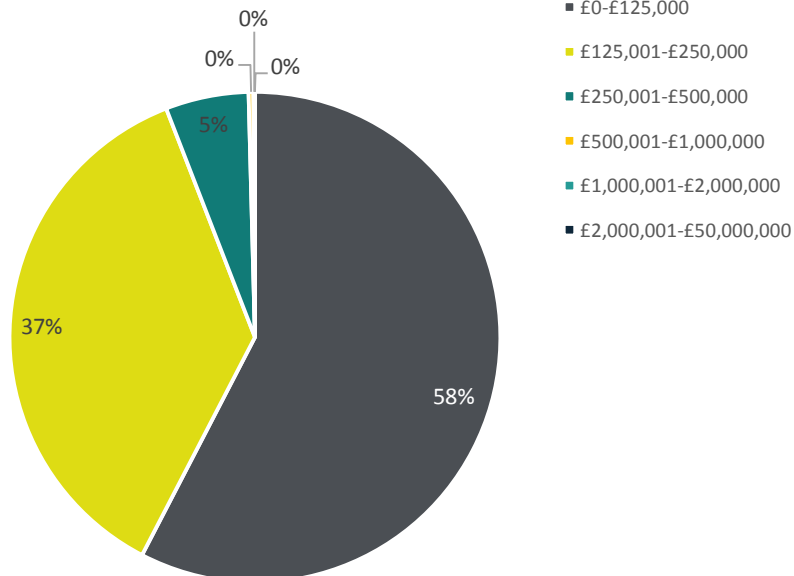
: Spicketts Battrick Solicitors are the second largest firm based in South Glamorgan in terms of transaction volumes.

Price bracket breakdown

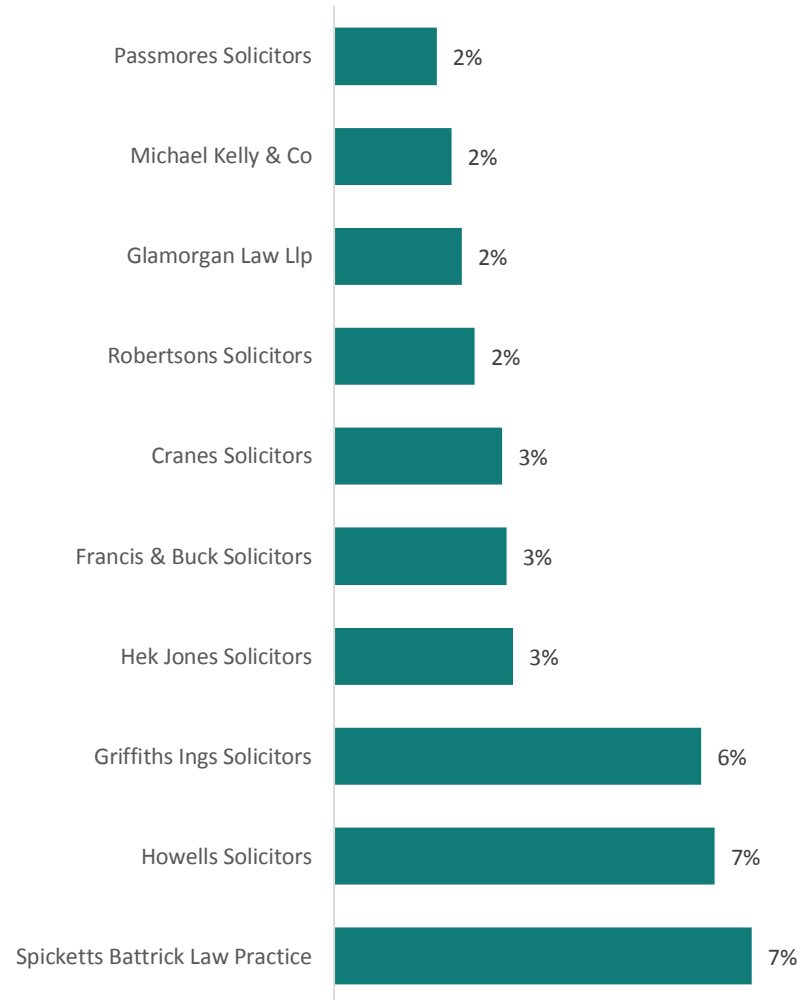
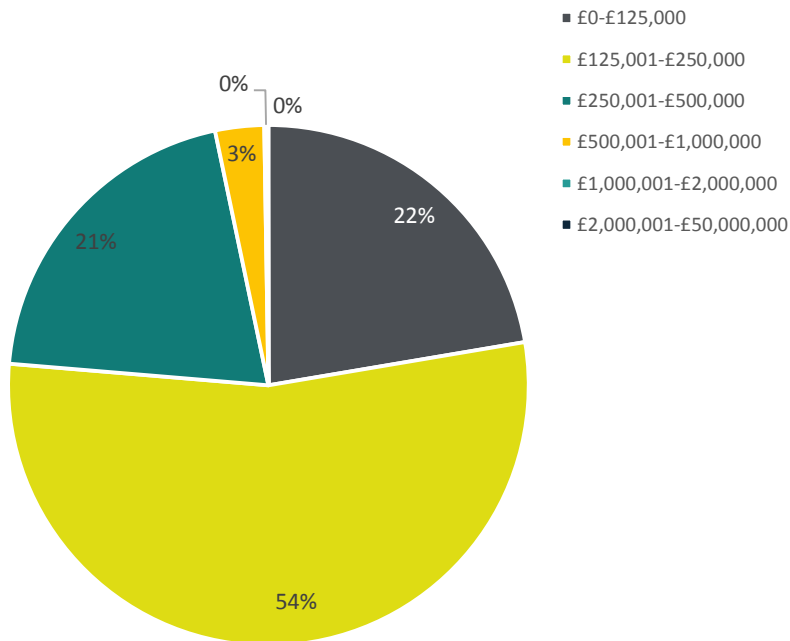


Local transactions of national branches South Glamorgan

: There were 7,865 purchases registered for properties in the local area during this time period by 683 different firms.

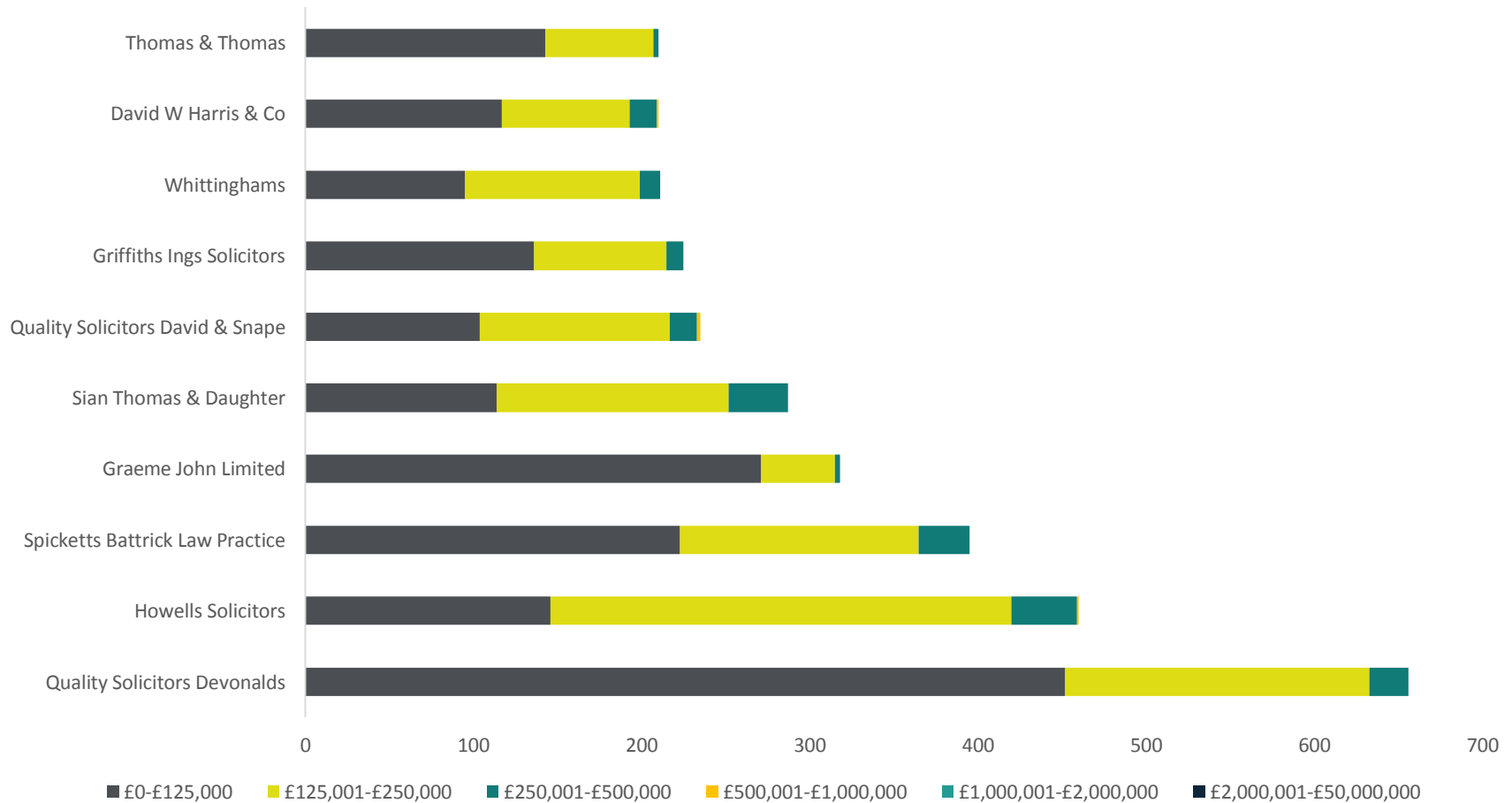
: Spicketts Battrick Solicitors are the top firm within South Glamorgan.

Price spread Mid Glamorgan

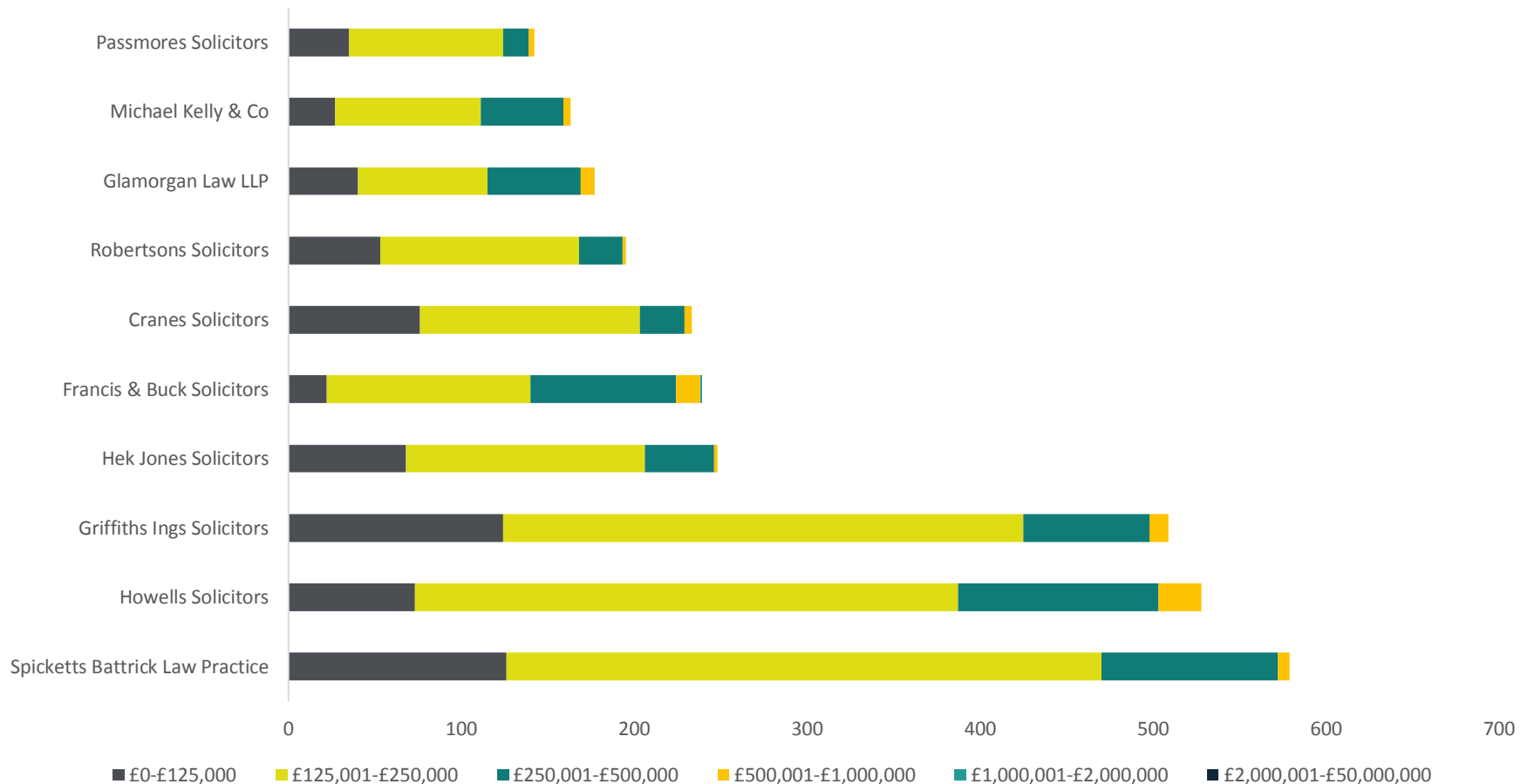
: This graph illustrates the breakdown of market share of the top 10 firms by price bracket

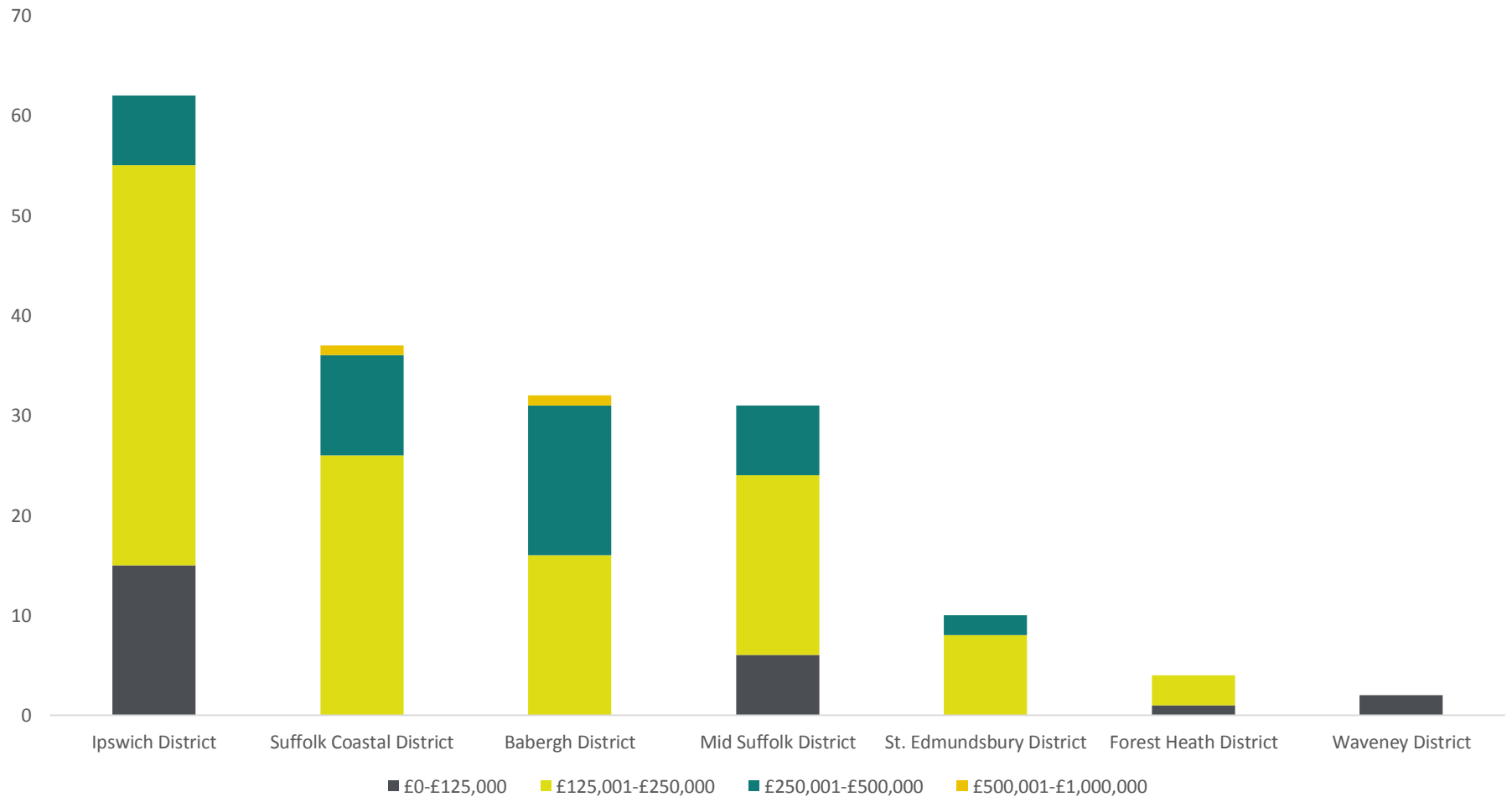
South Glamorgan

: This graph illustrates the breakdown of market share of the top 10 firms by price bracket



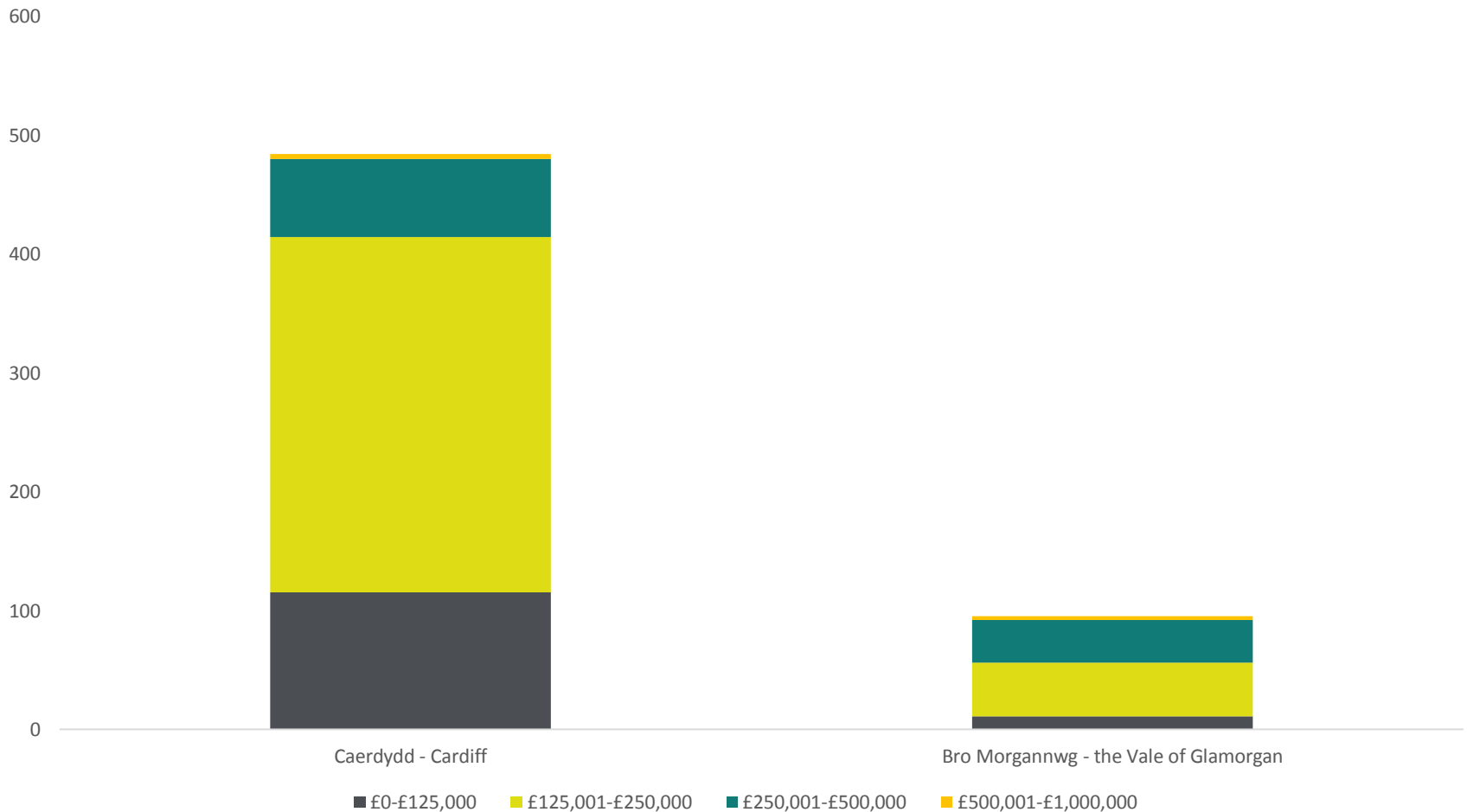
Price spread by District Mid Glamorgan
